#### We are most interested in receiving learning about:

#### - Your chosen TVET model

CTEVT, SEECS applied demand driven TVET model where local industry expert engage each and every activities. The revised curriculum was based on input provided by industry experts. Market oriented skills were shared by industry people to incorporate curricula. Entrepreneurial idea was also shared by private sector.

#### - How you have worked with private sector actors

One of the major element of TVET was industry people belongs with private sectors. The new skill adopted in market was institutionalized in curriculum through either preparation or revised with the help of them. Basically DSS/M were interact with private sector to acknowledge market driven skills through labour market analysis. The required resources were identified through discussion. The involvement of private sector in school committee plays vital role to mainstream the gap between curriculum and market. The private sectors facilitated to DSS/M for providing OJT, field visit, guest lecture and expert too.

#### - Transition to green economies

Green economics was emerging theme in Nepalese TVET. The private sectors trying to evoke green skill though they were required support about greener job. The identified green job were incorporated in curriculum during the preparation of curriculum where instructor and industry people were participated. The authorized division should aware about green job and skill before and after the preparation of curriculum.

All DSS/M were practiced about green economics within the limit of resources. DSS/M were incorporated green job when they were prepared customized courses. The concept of optimized utilization of resources were practiced during the conduction of training.

Story: Mr. Hark Bahadur Gharti a resident of Tikapur Kailali, Ward 1 is young and energetic person. During his past 10 year of life, he spend 7 years in Kuwait for employment and he return back to Nepal with the aim of self-employment. One two year of return, he became unemployed and thinking about enterprise establishment, at the same period of time little bit known about mushroom production and he started mushroom production with blank knowledge. During this period SEECs project announce about pilot training program notice and he grab this opportunity also. During the training period he know about mushroom production technique like mushroom house construction, mushroom diseases and their control method, vegetable gardening, goat farming etc. After completion of training SEECs project supported tools and equipment as per occupation selected by participants. Mr Gharti selected mushroom production and received tools as per his requirement and started his enterprise. Moreover, Mr Gharti construct mushroom house and started with 80 balls to produce about 800 kg mushrooms with probable income NRs 120000 in one season. After harvesting first lot of mushroom he has plan to produce again in 100 balls.

DSS/M were work together with private sector by following ways:

#### Analyze labor market

DSS/M were short listed the stakeholder who belongs to private sector and got appointment to identify new market oriented skill by structure questionnaire.

#### Revise curriculum

DSS/M were discussed with private sector to revise curriculum based on labor market analysis.

#### Identify required tools and equipment's.

DSS/M were discussed with private sector for requirement of tools and equipment based on curriculum.

 What processes and structures have you developed to collect information on market need or how to change a curriculum? How effective were these processes and how can the process be improved?

At new market oriented skill were identified from labor market analysis where number of industry people were invited with same occupation. A committee was formed to revise curriculum with the leadership of curriculum expert. They analyzed each task with necessary time and required tools and equipment. The first draft were verified with another level committee and endorsed after approved by curriculum authority.

- How did private sector actors and local authorities engage with your coordination structures or decision making processes for the project?

Private sector were invited through invitation letter with agendas and venue. Sometimes informal invitation were also practiced. They interact on the agenda in many times and made a conclusion for minute.

A sustainable plan was developed to endorse the activities of project after closes. The plan was submitted to management level of CTEVT. A short term plan will also prepare by schools and schools will prepare a plan to allocate budget and submit to CTEVT for budget approval.

What TVET models have you used in your project e.g. SAE, FBA- please provide a detailed description of how you delivered skills training and who you worked with? What were the challenges experienced and how did you address them?

CTEVT, SEECS practiced the inclusion of private stakeholders. Industry expert were participated each and every activities of project. The practiced SEECS model has

- 1. Formation of EICC
- 2. Collect the demanded occupations and skills
- 3. Incorporated the demanded occupation and skills in the existing curriculum and recommended by EICC to revise the curriculum
- 4. Get approval of the revised curriculum from CTEVT
- 5. Conduct the training focussed on GESI
- 6. Developed reports and disseminated to the stakeholders
- 7. Inclusion of industry people in school committee.

The methodology applied during the training were:

Illustration talk, lecture method, group work, case study, virtual demonstration, guided practice, individual practice, field visit and OJT.

The skilled instructor, graduate and industry people were involved during the implementation of training. The success story was shared by graduates and industry people. During the OJT, industry provided their platform and provided coaching trainees.

SEECS revised 9 curricula and among them two DSS's curricula (Local road supervisor) has only provision of OJT.BPMPI and GPI revised the curriculum of local road supervisor of 400 hrs. Out of 400 credit hours, 100 credit hours is provisioned for OJT and remaining were provisioned for theory and workshop practice.

For the placement of OJT, DSS sort listed the industry which may compatible with curriculum. DSS discussed with them and correspondence along with skill to be learn, attendance, agreement and follow up schedule. Industry appointed a supervisor to monitor and mentor the trainee. The placement capacity on OJT was decided by bilateral correspondence. During the OJT period, supervisor of industry people responsible to evaluate the trainee. DSS follow up the trainee by preparing the follow up schedule. During the follow up by DSS, they acknowledge about the performance of trainee by consulting supervisor and trainee.

The practice and approach of OJT is fruitful in vocational training. It enhance the work based learning and also allows to experience of industry behaviour and culture.

In future, the trainee who were participated in OJT may perform differently comparatively with other. They already familiar with industry culture and work method.
